

TERMS and CONDITIONS for **Caragui** Website Design Service

For our purposes, Caragui Design will be referred to as the “Designer” and the owner of the website/fancier will be referred to as the “Client” while a website design work will be referred to as a “Project” in the following Terms and Conditions.

It is understood that the Designer has offered his services to create a website for the Client and the Client has agreed to get Designer’s services based on the website design package agreed upon.

1. PAYMENT. Upon deciding on the website design package, the Client must pay in advance Fifty (50%) percent of the package price before the start of the Project and the balance of Fifty (50%) percent upon receipt of an email advice from the Designer according to number 4 below. The advance payment of Fifty (50%) percent is non-refundable in case the Client decides not to pursue or have the Project finished.

Payment may be made by PayPal or via Western union Money Transfer.

2.a. DUTIES OF THE CLIENT. The Client must provide the necessary information and data the Designer needs to start with and finish the Project. These information and data may include among others articles and information that will be used to create the Project. The Client must cooperate fully with the Designer for any and all information and data needed as required.

2.b. DUTIES OF THE DESIGNER. The Designer shall create the website design according to the design package agreed upon. The Designer shall also ensure that all designs, graphics, etc. are unique and customized to the particular Client and agrees to finish all work in a timely manner according to number 3 below.

3. PROJECT TIME FRAME. The Designer agrees to finish the Project within 3-4 weeks but dependent on the submission or availability of materials/data/information from the Client as mentioned in 2.a above.

4. PROJECT COMPLETION. A Project is deemed finished upon sending an email advice by the Designer to the Client that states;

- a) The Project is complete and
- b) The website is ‘live’ and available for viewing in the internet

5. UPDATES. Each package has its own free update period. The free update period starts upon Project completion according to number 4 above. Any updates will be done/finished within three (3) working days of confirmation of receipt of advice (by email) from the Client.

For updates after the free period, payment for the update must be made before any work is done. All packages charges a €7 per update. An update consists of any changes in any particular web page.

6. BIRD EDITING. Each package has its own free bird editing included. Each editing consists of the bird cleaned and a background replaced with one that is consistent with the website design. It also includes the bird's and owner's details (i.e. band number, name, sex, results, loft name). Montages are not considered included in the packages but are available upon request.

7. EMAIL ADDRESS/ES. Each package has its own free email account/s included. The Client will provide his email address/es of choice and the Designer will configure the same. The Designer will then provide the Client with the setting details for the Client to configure his email program of choice.

8. DOMAIN NAME. All packages include free domain name registration. The Client will provide the Designer with 3 choices to check for availability. The list must be structured according to the Client's preferences, i.e. 1st preference domain name number 1, 2nd preference domain name number 2 and 3rd preference domain name number 3. The Designer will register the 1st available domain name according to the Client's preference/list. The free domain name will have a .com extension only.

After the free registration period, a yearly domain name registration fee of €25 must be paid by the Client at least thirty (30) days prior to its expiration.

9. HOSTING. All packages include free website hosting. After the free hosting period, a yearly hosting fee of €35 must be paid by the Client at least thirty (30) days prior to its expiration.

All hostings include 500 MB disk space and a monthly transfer bandwidth of 5000 MB. Upgrades are available upon request.

UPON PAYMENT OF THE FIFTY (50%) ADVANCE PAYMENT, CLIENT HEREBY CONFIRMS THAT HE HAS READ, UNDERSTOOD AND AGREES TO THE ABOVE TERMS AND CONDITION.
